Michigan Department of Insurance and Financial Services has approved a revision of commercial auto rates for risks insured through the Michigan Automobile Insurance Placement Facility. This approval includes the introduction of the Car Service class. ISS will collect zip codes with the current rating territory codes.

The revised rates and class definitions will have an effective date of 02/01/18.
