Topic: Pennsylvania Voluntary Automobile Class Coding Revision

AIPSO has approved changes to Quota Determination to classify Low Speed vehicles in Pennsylvania as miscellaneous nonfleet personal vehicles.

Section 53 is amended to (1) expand the list of miscellaneous nonfleet personal vehicles for which voluntary base data must be reported to include low speed vehicles, and (2) exclude calculated car years for low speed vehicles from the calculated car years used for quota purposes.

Section 57 is amended to clarify references to (1) voluntary miscellaneous nonfleet personal vehicle and named nonowner liability premium excluded from Voluntary All Other Automobile Liability Net Direct Written Premium used for Pooled CAP participation and (2) voluntary miscellaneous nonfleet personal vehicle physical damage premium excluded from Voluntary All Other Automobile Physical Damage Net Direct Written Premium.

This new class code 9470 is applicable to policies effective **May 1, 2018**.

The attached coding on page 98 is reflected in the Voluntary Automobile Statistical Plan.
